Alas for the mutability of human affairs! But yesterday people were making such rapid fortunes at Internal Debt and land-speculations that one can hardly believe what a change has occurred in 24 hours.

The feeling of uneasiness in commercial and general circles was not abated by a rumor that the B. Ayres authorities this morning closed their port against us, without any previous notification.

An unpleasant quarrel has occurred between the employees of the Central Uruguay Railway and the Commissary of Paso Molino, which might have led to serious consequences.

The boatmen who were landing some of the Charrua passengers have been sent off in quarantine, while many of the passengers are walking about the town.

We are anxiously waiting to hear of the Cable expedition from the other side: the length is 112 miles.

The excellent article on the National Bank in the Nacional of Thursday evening was read in commercial circles with much approval.

The Indian Daily News says—The most remarkable engineering feat now in progress is the crossing of the Andes by the Lima and Oruro railroad.

We received a letter yesterday from Mr. Billiat in reference to the Paraguayan emigrants which we regret we cannot publish to-day, owing to the great pressure on our space.

Mr. J. M. Rubio and Co. are about to start a line of steamers to run between Buenos Ayres and Ajo.
