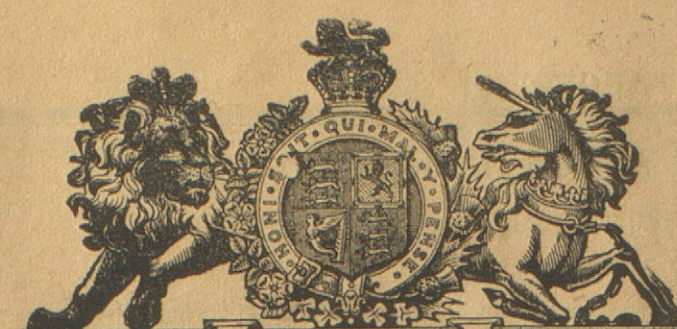

## TELEGRAMS

TO STANDARD

London, 20th.—Many of the Liberal Unionists will return to Gladstone and support anything except Home Rule for Ireland. Several of them have said so to their political friends.

Mr. Gladstone has declared that, when Parliament re-meets, he will not support the Home Rule bill. He is one man one vote. He adds that this reform will not reduce the number of Irish members.

Hall, the Australian Champion, has been published in the morning.

Rome, 20th.—The papers praise greatly the naval manoeuvres in the Mediterranean, especially the rapidity with which the crews were mobilized without any hitch.

Two fatalities of infantry have been sent to Sicily to put down the banditti, two or three gangs having appeared in different parts of the island.

Naples, 20th.—The travellers Ferri and Botto have left to explore the river Juba in East Africa, South of Abyssinia.

Rome, 20th.—Nine soldiers have been arrested at Caserta on suspicion of being anarchists or in connivance with them. No importance is attached to the affair.

London, 20th.—Some of the South American Ministers did not attend Lord Rosebery's first reception at the Foreign Office.

Berlin, 20th.—The probable resignation of Caprivi is again spoken of, as the Emperor is disgusted with his action in the dispute with Bismarck and the exhibition affair. It is also thought that the only way to appease Bismarck and prevent his appearance in the Reichstag to attack the Government.

Paris, 20th.—Telegrams from Madrid say that Colonel Dods has made a reconnaissance in arms in the interior. The gun-battle Topaze and Emerald went up the river Oueche with the troops.

Some Dahomey soldiers were captured. The King has refused to the interior, with a great part of his forces, to an entrenched camp near Carra.

As all the reinforcements have been sent, the French will soon make a decisive attack, as the troops are in the best health and spirits.

## THE AGRARIAN LEAGUE.

This is the name of a new and powerful association which is to hold its first meeting at the Rural Society's rooms, 883 Calle Cangallo, at 8 o'clock to-morrow evening. The necessity for such a League is too palpable to need demonstration, since the condition of rural affairs is scandalous in the extreme.

It is here to advocate the failure of the Rural Society, or to enquire into the causes. That Society was started in 1896 in the midst of the most brilliant expectations, and its career of 26 years has been a blank. When we reflect that its roll of 1,120 members includes the estates and men of most weight in the community (whose properties in this province represent a value of more than 500 millions of dollars) we cannot but marvel and regret that Buenos Ayres rural interests have been allowed to fall so low.

It is this feeling that prompts the gentlemen who are founders of the Agrarian League to make a bold effort for the regeneration of this once prosperous and well-administered province. Their programme is sufficiently ample, viz:—

1. Construction of roads, bridges and canals.

2. Reduction of Railway tariffs.

3. Reduction of taxes, especially those on land and cattle.

4. Protection for life and property.

5. Opposition to false loans or obligations.

6. Reformation of the police and local authorities.

7. General survey and valuation of the province.
