In one of the daily papers a paragraph has appeared stating—"The war against Lopez is over now that it is a well-known fact that the "Generalissimo" took golden balls worth six thousand contos of reis to destroy Humaitá and Assumption, and that he has an open credit of fourteen thousand contos to enable him to dethrone the despot who is costing Brazil so much blood and money.

In this there may be immense glory, but the country will grieve for a long time before it can raise the money to pay all these expenses!"

Dr. Cochrane of Santos publishes the following in the papers;—"Mr. Editor, I request the publication of the following fact which on my own responsibility I bring before the public and leave them to appreciate it without offering any comment myself.

At the beginning of last month (Dec.) there met me a man, whom I did not in the least know, accompanied by a daughter and grand-child, all literally clothed in rags, who said they came to implore my charity and good offices.

This was the first time that I had seen the man, but the extreme affliction in which this poor old man, broken down by age and worn out by hunger and fatigue appeared before me, shocked me excessively.

He told me that he had come after his son who had been designated as one of the National Guards to go to the war, while this son was his only support, and that a year ago he had been designated but afterwards declared exempt by the President.

I made a petition of this tenor to the Commander in Chief who replied as follows: "On the 7th Dec. 1865 the President of this province ordered the National Guard Manoel Antonio Borges to be transferred from the first to the second class, as he had proved that he was an only son and his father over seventy years of age; the petitioner must therefore apply to the President of the Province."

I drew up a new petition, addressed to the President, which together with the information of the Commander in Chief, I forwarded immediately to S. Paulo. Weeks passed by without my being able to obtain from H. E. the President any reply to my petition.

This very day at 10 a.m., I found that my petition had still no reply, and half an hour afterwards I saw the unfortunate Borges pass by in irons, in the midst of recruits and conscripts, and subsequently embark for Rio Janeiro.—This is only one of the numberless acts of injustice and cruelty which the papers have published as committed by the President of the Province of S. Paulo, and yet Dr. Tavares Bastos boasts of being one of the head centres of the Libertad Party!!

In one of the daily papers a paragraph has appeared stating—"The war against Lopez is over now that it is a well-known fact that the "Generalissimo" took golden balls worth six thousand contos of reis to destroy Humaitá and Assumption, and that he has an open credit of fourteen thousand contos to enable him to dethrone the despot who is costing Brazil so much blood and money.

In this there may be immense glory, but the country will grieve for a long time before it can raise the money to pay all these expenses!"

Dr. Cochrane of Santos publishes the following in the papers;—"Mr. Editor, I request the publication of the following fact which on my own responsibility I bring before the public and leave them to appreciate it without offering any comment myself.

At the beginning of last month (Dec.) there met me a man, whom I did not in the least know, accompanied by a daughter and grand-child, all literally clothed in rags, who said they came to implore my charity and good offices.

This was the first time that I had seen the man, but the extreme affliction in which this poor old man, broken down by age and worn out by hunger and fatigue appeared before me, shocked me excessively.

He told me that he had come after his son who had been designated as one of the National Guards to go to the war, while this son was his only support, and that a year ago he had been designated but afterwards declared exempt by the President.

I made a petition of this tenor to the Commander in Chief who replied as follows: "On the 7th Dec. 1865 the President of this province ordered the National Guard Manoel Antonio Borges to be transferred from the first to the second class, as he had proved that he was an only son and his father over seventy years of age; the petitioner must therefore apply to the President of the Province."
