This Loan occupies an exceptional position. Its amount has now been reduced to about £800,000, and it is being paid off half-yearly by an accumulative sinking fund.

The accounts received from the River Plate all tend to confirm the views hitherto expressed as to its rapidly rising prosperity.

On this latter point there are some differences, but entirely immaterial to the great principle under discussion, which is that—

"Arbitrators are supposed to be named, and to proceed to adjust the matters in dispute upon the enlarged principles of justice and good conscience, for the purpose of preserving harmony and preventing litigation among men".

We will now appeal to railway law and practice, in cases absolutely identical of the position of the Wharf Co. and the Northern Railway towards each other: i.e. an interchange of traffic between countermining lines.

The English statutes, and especially the Railway and Canal Traffic Act (17 and 18 Vict., c. 31), have attempted a very strict supervision.

Arbitration is also decreed by law in England for carrying the mails; that is to say, when any company cannot agree with the Post-Master General on the price for such service, it is left to arbitration.

Here is exactly our case. The evident intent of the law, authorizing the connection of the Wharf Branch with the Northern Railway, was for the purpose of through traffic, and it requires all the dog-in-the-manger policy of the management of that line to teach us the want of a positive law obliging it to do so, inasmuch as we now know that it will not learn its true interests in any other way.

The Railway Clauses Consolidation Act provides in detail for the use of railways for all persons who may choose to put carriages thereon, upon payment of the tolls demandable subject to the provisions of this act (4 and 5 Vict., c. 55), and by no means leaves it to the arbitrariness of any one company to dictate to the others.

In the United States, where English legislation on railways has been more blindly followed than in any other country, we find almost identically the same laws for the same effect.

ON 'CHANGE

The Bond market ruled firm today, and prices improved slightly. Sr. Dominguez was sworn in today at the Government House as Minister of Hacienda.

National Bonds opened at 64 1/2 for the end of the month, and closed at 65 1/2—76, 700 sold. For Saturday 10,000 at 65.

For cash there was nothing done; the market rules quiet, but firm. About £15,000 passed in Exchange on England at 49 1/2.

Money rules easy, and discount brokers report that the first class paper can be done at 7 per cent. without going to the Provincial Bank.

It is said that next week the National Government will pay very heavy 'vencimientos' falling due at one of our private banks, and this will also tend to making money more abundant.

There is a very loud complaint about Municipal Bonds and the interest not having been paid yet. It appears there are buyers at 90, but with guarantee from seller that the interest and amortization will be paid next week.

The wool business for the fortnight shows a slight improvement on the previous month. The quantity in deposit is estimated at 600,000 arr.

Prices have improved some \$2 per light mixed. Fine wools are the same. The sheep appear to have got hold of the Trans-Andean Telegraph shares; prices fall to-day to 5 per cent., and it was even said down to 2 per cent. premium.

The sudden fall in maize was much spoken of; prices have fallen from 23 to 180, and if this fall is maintained, several speculators in the plaza will lose heavily.

ALLOW ON THE 1st JANUARY IN THE ANTWERP MARKET

was 4000 pipes against 300 in 1869 and 670 in 1868, on the way for Antwerp 4,800 pipes.

The export of horns from Antwerp during the year 1870 amounted to 1,078,000 against 1,140,000 in 1869, and 900,000 in 1868; prices firm and market looking up.

British Naturalisation Acts (1870.)

NOTICE TO BRITISH SUBJECTS. The attention of British subjects, who have become naturalized in the Republic of the River Plate, is called to the 4th and 6th Clauses of the 'Act to Amend the Law relating to the legal condition of aliens and British subjects' (33 Vict., cap. 14, May 12th, 1870.), and which are as follows:

HOW BRITISH-BORN SUBJECTS MAY CEASE TO BE SUCH. Any person who by reason of his having been born within the dominions of Her Majesty is a natural-born subject, but who also at the time of his birth became under the law of any foreign state a subject of such state, and is still such subject, may, if of full age, and not under any disability, make a declaration of his intent to renounce his naturalization, and from after the making of such declaration of intention shall cease to be a British subject.

EXPATRIATION. Any British subject, who has at any time before, or may at any time after the passing of this Act, while in any foreign state, and not under any disability, voluntarily become naturalized in such state, shall from and after the time of his so having become naturalized in such state, be deemed to have ceased to be a British subject, and be regarded as an alien, provided—

1. That where any British subject has before the passing of this Act voluntarily become naturalized in a foreign state, and yet is desirous of remaining a British subject, he may, at any time within two years after the passing of this Act, make a declaration that he is desirous of remaining a British subject, and upon such declaration being made, and upon his taking the oath of allegiance, the declarant shall be deemed to be and to have been continuously a British subject, with this qualification, that he shall not be held to be within the limits of the foreign state in which he has been naturalized, be deemed to be a British subject, unless he has ceased to be a subject of that state in pursuance of the laws thereof, or in pursuance of a treaty to that effect.

2. A declaration of British nationality may be made, and the oath of allegiance taken as follows: that he is to be regarded as an alien, provided—
