management. In former years he has undoubtedly done much hard physical labor; now he works hard in directing and planning. Unlike most Western farmers, he keeps a careful record of the quantity of produce grown each year, quantity sold, prices, expenses, &c.

This account is of the farm of not the man, and of the home life it need here only be said that there is an opportunity for enjoyment; a roomy, comfortable farm-house, a good orchard, small fruits, &c.

Third farm lies near the thriving little city of Oshkosh. This is in its favor. It also lies near a great lumber region and not very far from extensive mines. More than usually good markets have thus been secured.

The soil is good, but not better than that of very many other farms. In finding out what the land was well adapted to produce, and that for which there was a permanent market, forming a plan in accordance with the situation, and then sticking to it following this plan—simply these things explain this instance of much more than usual success in farming.

There are any reason why such a man may not have equal success on many other farms. —Y paper.

There is more produce business done in San Nicolas than in the second city of the Republic. The saladeros and granerías are all hand to work; the port is crowded with shipping; new hands are arriving every day; employment is abundant; and we learn now that more than 117 new houses are being constructed in this modest town.

The public market is rapidly approaching completion; and the new prison, planned by Mr. Bunge, will be immediately commenced. The flour-mill, also, is doing a large business. We could wish we had more of this in this province like San Nicolas.

It has been suggested that the Provincial and Argentine banks should have the square in Calle San Martin, between Fríed and Cangallo, paved with asphalt pavement as at present laid down in Calle Florida.

The entire expense for two such large institutions as these banks would be a mere bagatelle, and if the example was set it might lead to similar improvements in the adjacent blocks; for instance the Calle Cangallo, between San Martin and Florida Messrs. Maveroff, Diavillo and Maun might well afford to make that part of the street asphalt.

Further up in the same street Messrs. Canabasso and Antonio Lopez might also do the same, whilst in the Bolso block the Hypothecary Bank and the Bolsa might well afford to them to make a similar improvement. A very little public spirit is all that is required, for as to the expense, it amounts to nothing.

We notice in the new budget of the province that the monthly expenses of the public credit department—put down at 150,000 monthly or 1,800,000 dollars per annum; this does not seem expensive for so important an office.

The law has been passed and promulgated authorizing the Government to invest the sum of two millions three hundred and fifty-eight thousand nine hundred dollars for the purchase of a new Police, also to pay the sum of 3,800,250 m/c for the purchase of the Sanatorio Modelo, and to spend on same in fitting it up for a woman's hospital the sum of \$1,139,750 m/c.

An abstract of partial returns of the census of the United Kingdom of Great Britain and Ireland, taken April 3, with reference to the night of Sunday, April 2, 1871, gives— "The population of the United Kingdom increased during the decade from 1851 to 1861, at the decennial rate of 6.74 per cent; during the decade from 1861 to 1871, at the decennial rate of 8.60 per cent, or at the annual rate of 0.83 per cent.

In England and Wales the decennial rates of increase for these periods were respectively 12 and 13 per cent. In the United States the decennial rate of increase from 1860 to 1870 was 22.6 per cent.
